### **Consolidation of Capital – Ex Date Information**

Further to the stock exchange announcement on 21 October 2015, African Petroleum advises that its shares are trading on an ex-consolidation basis from 26 October 2015. The last day of trading pre-consolidation is today.

The Company's capital is being consolidated on the following basis:

- a) every ten (10) shares be consolidated into one (1) share; and
- b) every ten (10) share options be consolidated into one (1) share option and the exercise price of each share option be amended in inverse proportion to this ratio.

The Company's shares have no par value. Security holders will be sent a new holding statement indicating the new number of securities they hold on a post-consolidation basis on or about 4 November 2015.

The Company's assets are located in proven hydrocarbon basins in the West African Transform Margin, and the Atlantic Margin, where several discoveries have been made in recent years. With a combined net acreage position of 30,378km<sup>2</sup> through its licences in Côte d'Ivoire, Liberia, Senegal, Sierra Leone and The Gambia, the Company has matured its portfolio through the acquisition of more than 18,500km<sup>2</sup> of 3D seismic data and successfully drilling three deep-water wells, one of which was the first hydrocarbons discovery in the offshore Liberian – Sierra Leone Basin.
